



## WAIVER OF LIABILITY

TO OUR CUSTOMER:

IN TODAY'S CRANE RENTAL BUSINESS, CRANES HAVE BECOME LARGER AND HEAVIER TO MEET CUSTOMERS' NEEDS. THE LIABILITY FOR DAMAGE TO ASPHALT/CONCRETE PARKING LOTS, UNDERGROUND UTILITIES, DRIVEWAYS, CURBS AND GUTTERS HAS BECOME A PROBLEM FOR THE CRANE COMPANY AND THE CONTRACTOR.

OUR SALESPEOPLE, CRANE OPERATORS AND OILERS WILL WORK WITH THE CONTRACTOR TO MINIMIZE ANY DAMAGE TO ANY BUILD UP AND WORK AREAS. BOB TURNER'S CRANE SERVICE WILL SUPPLY MATS, STEEL PLATES OR OTHER ITEMS AT COST TO THE CONTRACTOR TO MINIMIZE DAMAGE, IF SAID EQUIPMENT IS REQUIRED.

WHILE WORKING ON THIS PROJECT, BOB TURNER'S CRANE SERVICE, INC. WILL NOT BE RESPONSIBLE FOR DAMAGE TO THE FOLLOWING:

1. PARKING LOT SURFACES, SIDEWALKS AND/OR DRIVEWAYS WHILE ENTERING, LEAVING OR MOVING THE LOADS OVER THESE AREAS
2. PUBLIC STREETS, PRIVATE ROADS, UNDERGROUND VAULTS, GUTTERS, UNDERGROUND UTILITIES OR ANY OTHER UNDERGROUND SYSTEMS, UNDERGROUND PARKING STRUCTURES, WHILE ERECTING THE CRANE OR DURING MOVEMENT OF CRANE ON THE WORK SITE
3. IRRIGATION SYSTEMS, LAWNS AND SHRUBBERY THAT MAY BE DAMAGED IF THE CRANE NEEDS TO CROSS THESE AREAS TO WORK PER CONTRACTOR REQUEST
4. HOUSE AND SURROUNDING AREAS.
5. LOAD, INCLUDING DEAD TREES, CHIMNEYS, ROCKS OR OTHER ITEMS THAT COLLAPSE OR BECOME REMOVED FROM THE RIGGING.

THE CONTRACTOR HAS BEEN NOTIFIED THAT THE MOVEMENT OF HEAVY EQUIPMENT MAY CAUSE DAMAGE TO JOB SITE AREAS.

THE UNDERSIGNED AGREES TO INDEMNIFY, HOLD HARMLESS, AND RELEASE BOB TURNER'S CRANE SERVICE, INC., IT'S AGENTS AND EMPLOYEES FROM CLAIMS, LOSS DAMAGE, SUIT OR JUDGEMENTS FROM ANY SUCH DAMAGE DURING THE USE OF THE EQUIPMENT AT THE FOLLOWING JOB LOCATION, EXCEPT IN ANY INSTANCE OF SOLE NEGLIGENCE OR WILLFUL MISCONDUCT OF BOB TURNER'S CRANE SERVICE, INC. EMPLOYEES.
